## SEWP V CONTRACT OVERVIEW

The Solutions for Enterprise-Wide Procurement (SEWP) V, is a multiple-award Government-Wide Acquisition Contract (GWAC) vehicle that is available for use by NASA, all federal agencies and the federal agency support service contractors. The contracts are managed and administered by NASA Goddard Space Flight Center (GSFC) at the NASA SEWP Program Management Office (PM). SEWP contracts focus on providing Information and Communications Technology and Audio/Visual products and services. Currently there are over 140 pre-competed Prime contract holders and millions of products on contract available to customers. These products and services include servers, peripherals, software, supporting equipment and associated training, installation and implementation solutions.

The SEWP V GWAC is subject to Fair Opportunity as required by FAR Part 16. Each Contract Holder shall be given Fair Opportunity to be considered for each order exceeding the micro-purchase threshold and issued under multiple award contracts.

Fair Opportunity to all Contract Holders within one or more SEWP Groups or set-asides is required. There is no requirement to obtain 3 quotes as long as all Contract Holders within a Group or set-aside were provided opportunity to quote.

The SEWP online Quote Request Tool is the recommended method to assist in meeting Fair Opportunity and to augment the required decision documentation.

## POLICY AND PROCEDURAL INFORMATION

### Ordering Process

1. Customer sends order to SEWP Program Management Office (PMO), [sewporders@sewp.nasa.gov](mailto:sewporders@sewp.nasa.gov) or fax order and SEWP Fax Cover Sheet to: (301) 286-0317
2. SEWP PMO reviews and enters the order information into SEWP database and assigns SEWP Tracking Number (STN)
3. SEWP PMO sends the order to iGov Technologies, Inc.
4. iGov Technologies, Inc. acknowledges receipt of order

5. iGov Technologies, Inc. begins fulfillment of order

**Warranty**

In accordance with iGov’s SEWP contract, iGov shall provide an extended warranty, which can be purchased and begin at any time during the standard commercial warranty period up to and including the end of the commercial warranty period. Extended warranty packages may be invoiced and paid at the start of the warranty period. This extended warranty shall provide coverage based on the standard commercial warranty.

At the Government’s discretion, the Government may order, at any time during a warranty period, monthly maintenance at a Discounted Monthly Extended Warranty amount in lieu of the extended warranty.

**Software Maintenance / Product Extended Warranty as a Product**

Product and software maintenance, warranty and licensing shall be treated as a commercial product unless such product is priced on a usage basis; e.g. maintenance on a printer based on usage must be invoiced monthly. Software maintenance as a product includes the publishing of bug/defect fixes via patches and updates/upgrades in function and technology to maintain the operability and usability of the software product. It may also include other no charge support that is included in the purchase price of the product in the commercial marketplace. No charge support includes items such as user blogs, discussion forums, on-line help libraries and Frequently Asked Questions (FAQ), hosted chat rooms, and limited telephone, email and/or web-based general technical support for users self diagnostics.

Software maintenance as a product does NOT include the creation, design, implementation, integration, etc. of a software package. These examples are considered software maintenance as a service and are to be billed monthly.
